

ARC'TERYX ACADEMY & GORE-TEX® PRODUCTS TRAIL RUNNING CLINIC RAFFLE

Official Participation Rules. These Official Participation Rules ("Participation Rules") govern participation in the Arc'teryx Academy & GORE-TEX® Products Trail Running Clinic Raffle ("Raffle"). By participating, each participant acknowledges and accepts these Participation Rules.

Promoter. The Raffle is organized by W L. Gore & Associates GmbH, Aiblinger Straße 60, 83620 Feldkirchen-Westerham, Germany (the "Promoter").

Eligibility. Participation is open to natural persons aged 18 years or older with permanent residence within the European Union. Employees, officers, representatives of the Promoter, affiliated companies, Arc'teryx Academy, and their immediate family and household members are not eligible. Participation is free, not dependent on any purchase, and independent of answering marketing questions.

Raffle Period and Participation. The Raffle begins on 20.06.2025 and ends on 25.06.2025 at 11:59 PM CET. To participate, participants must comment on the collaborative Instagram post advertising the Raffle, as posted by Arc'teryx Academy and the GORE-TEX Brand. Multiple comments by the same participant will count as a single entry. Entries using multiple accounts or false identities will be disqualified. Additionally, the Promoter reserves the right to exclude participants from the Raffle at its reasonable discretion, particularly in cases of manipulation, violations of these Participation Rules, unfair conduct, or provision of false or misleading information related to participation.

Prizes. Three winners will receive participation in an special trail running clinic (the "Clinic") hosted in collaboration with Arc'teryx Academy. The Promoter covers costs directly related to the Clinic, including guides and instruction. Winners are responsible for all other expenses, including but not limited to travel, accommodation, meals, incidental costs, and applicable taxes. Prizes are non-transferable, cannot be exchanged, and no cash equivalent will be provided.

Winner Selection. Winners will be randomly selected from all eligible entries within 25.06.2025

Winner Notification. Winners will be notified via Instagram direct message within 25.06.2025

Prize Acceptance. Winners must confirm their participation to the Promoter within two (2) days of notification. Failure to confirm within this period results in forfeiture of the prize.

Alternate Winner Selection. If a winner does not respond within two (2) days after notification, their claim to the prize will lapse. The Promoter reserves the right to select an alternate winner from eligible entries.

Replacement Prize. The Promoter reserves the right to provide an alternative prize of equal or greater value, or amend the Clinic details, if necessary due to legal reasons or unavailability.

Early Termination. The Promoter reserves the right to terminate or modify the Raffle at any time without prior notice due to technical or legal reasons.

Limitation of Liability. Participants fully release Instagram from any liability related to this Raffle. Instagram does not sponsor, endorse, administer, nor is associated with this Raffle. Participants must comply with Instagram's rules, particularly avoiding inaccurate tagging or misleading actions. Participation in the Clinic may be subjected to reasonable limitations of liability.

Data Privacy. By entering the Raffle, you consent to the processing of your personal data by the Promoter for the purposes of selecting winners, notifying them, and delivering prizes.
